Player's Commitment to Munciana Volleyball Club

- I understand that Munciana VBC selects the most appropriate and available coach for my team, age group, and level of competition and that any specific named coach for my team is not guaranteed.
- I commit to attend all practices and tournaments unless prior agreements are made with the coach.

Conduct and Playing Time

- I have read the Munciana Player Code of Honor and Parent Code of Conduct and agree to abide by it or face
 participation restrictions or even club expulsion without a refund for a violation of any club policy by the parent or the player.
- I understand that playing time is solely the coach's discretion and that payment does not guarantee playing time in tournaments.
- I understand and agree to the club's 24-hour rule of approaching coaches and administrators 24 hours after a tournament to offer comments on coaching decisions or tournament outcome and will follow the club process for giving feedback.
- If there is an issue with the team or coach, I agree to follow the following protocol. 1st: Set-up a player/coach meeting, 2nd: Set-up a parent/player/coach meeting, 3rd: If the issue is not solved, set up a meeting with the player/coach/parent/club directors.
- I grant Munciana VBC permission to use the player's name, film, photos or likeness for promotional and marketing purposes.

- I understand that no refund of fees paid will be given for players leaving the team, voluntarily or involuntarily, for any reason.
- I agree to pay a \$25 check handling fee for each cash/check payment and \$40 fee for all returned checks.
- In the event legal proceedings are instituted to enforce performance of any terms of this contract, and it is determined by the Court that one of the Parties has violated the terms of this Agreement without just cause, then the prevailing party shall be entitled to payment by the other party of the whole or part of His/Her reasonable cost in the proceedings (including attorney fees) as determined by the Court.

- 3. Music is not listened to on the court while warming up or officiating.
- We will be the best officiating team in the country. Be ready to officiate before warm-ups, be attentive, polite and prepared. 4
- 5. Obey all playing site rules wherever we compete.
- 6. When you are at a tournament site, you are there with your TEAM.
 - Interact with your teammates.
 - Parents are not allowed near any Munciana bench during a tournament. The benches are for teams and the bleachers are for b. parents.
 - All team members must stay until all playing and reffing assignments are completed unless approved by the coach. C.
- 7. Tournaments are mandatory. Prior to the season inform the coach of preplanned conflicts such as a school event or major religious conflict. School testing, such as SAT/ACT, needs to be scheduled on non-tournament weekends. If a family emergency arises, contact your coach and parent rep immediately.
- 8. Coaches will announce the expected arrival time for an event to their teams prior to the event. All athletes are expected to arrive on time. If this is not possible, coaches should be notified in advance.
